PRIVACY POLICY

Terra Vista Management, Inc. ("TVM" or "we" or "us") is the property manager and operator for various managed properties listed on TVM's website (the "Properties") and is also the manager of certain entities that directly or indirectly have an ownership or management interest in the Properties. TVM supplies all the employees for the Properties. We believe in protecting personal information and privacy.

We take pride in the relationships we have been able to build with our employees and our Properties' owners, managers, customers, occupants, tenants, licensors, concessionaires, and guests, and we have established the following Privacy Policy ("Policy") for their benefit and protection. Please read this Policy carefully and in conjunction with our <u>Terms of Use</u> and ensure that you understand this Policy and such terms before you start to use our Website (as defined below) or our services.

This website, https://www.terravistamgmt.com, and any related social media and online locations such as Facebook, X (formerly known as Twitter), Instagram and YouTube, and any subdomains, content services thereof, or any other replacement website (individually and collectively, the "Website") is managed by TVM.

By accessing and using our Website or services, you acknowledge that you have read and understood the content of this Policy. Accordingly, if you do not agree to the terms of this Policy, do not use our Website or services.

We obtain and process personal information on behalf of, and at the instructions of, our Properties and managed entities. Certain of such Properties and entities will be considered businesses under the California Consumer Privacy Act of 2018 ("CCPA"), and to the extent applicable to such Properties or entities, we will be considered as the service provider. Their privacy policies also will apply to the processing of your information, and we encourage you to read their privacy policies.

I. Collection of Information

1. Categories of Information We Collect

We collect the following categories of information:

- **Personal information categories,** such your name, phone number, and email address
- Internet or other similar network activity, such as browsing history or information on your interaction with a website or application
- Geolocation data, such as physical location
- Inferences drawn from other personal information, such as personal information reflecting a person's preferences

We also collect the following categories of information on behalf of the Properties:

- **Identifiers**, such as a first name, last name, email address, physical address, including your street, city and zip code, and/or account name
- **Personal information categories,** such as names of all campers (including all adults and children), applicants, occupants, tenants, signatures, telephone or mobile numbers, driver's license or passport information, emergency contacts, and other documents to verify identities
- Commercial information, such as records of reservations, purchased, obtained, or considered; if reserving an RV campsite, RV make, model, size, and license plate; if leasing space in a mobile home park, the mobile home make, model, year, serial and VIN number, size and dimensions, modifications and renovations, ownership status, lienholder records (title or financing liens), registrations, proof of ownership (title documents and bills of sale), inspection and maintenance records, utility information, insurance information, lease and rental agreements; if bringing other vehicles, vehicle registration number and vehicle information; if bringing a boat, boat information and boat registration number; if bringing pets, number, breed, color, size/weight, name, vaccination history, and licensing; other logistical, purchasing or consuming histories or tendencies (including past stays, frequency of visits, length of stays, and preferred sites and amenities); full or partial payment card information; background checks, credit checks, and financial records; feedback, complaints, accommodations, surveys, liability waivers, compliance with rules and regulations, and incident reports
- **Internet or other similar network activity**, such as browsing history or information on your interaction with a website or application
- Geolocation data, such as physical location and usage patterns of amenities
- **Sensory Data**, such as a photograph, or a video or audio recording, including security surveillance
- Inferences drawn from other personal information, such as personal information reflecting a person's preferences

We also collect the following additional categories of information on behalf of our employees:

• Additional Employee Information, such as date of birth, social security number, marital status, citizenship status, driver's license or passport information, emergency contact information, bank account information for direct deposit, vehicle information, employment history, training certifications, tax forms, credit checks and other background screenings, email and internet usage during work hours, device usage (including without limitation, keystrokes), attendance records, disciplinary actions, grievances or complaints, diversity, equity and inclusion data, and employee surveys

Except in connection with diversity, equity and inclusion (DEI) efforts, with respect to our employees, we do not (and do not want to) collect any sensitive data that includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, or information about your health, genetic or biometric data.

2. Source of Personal Information We Collect

We directly collect personal information from you when you interact with our Website:

• Information when you reach out to us in our contact form, including your name, phone number, and email address

We may collect personal information from you when you interact with the Properties:

- Information that is provided when a reservation or appointment is made online or in person
- Information is requested or a product or service is purchased from us, including names, addresses, telephone numbers, email addresses, license plate numbers, registration numbers, boat license numbers, passwords, and payment information
- Information that is provided when you respond to customer surveys, and when customers, guests, applicants, occupants, tenants or residents register at the front desk or visit the management office, fill out forms or otherwise share information
- Information that you provide to our third-party service providers
- Photos, videos and other digital media taken by us of guests or visitors visiting the Properties or tenants, residents or occupants at the Properties. If you would like us to remove any photo or video of you, please contact us at privacy@terrav.com in writing
- Digital images and photos that people post when they interact with or post to our social media accounts
- Information you provide when you create an account with us or enter a contest or sweepstakes

We may collect personal information from you when you apply for or accept a job:

- Information required in a job application for TVM
- Information required during onboarding at TVM
- Information required from time to time during the term of employment at TVM
- Information required upon separation from TVM

3. Device and Usage Information

Device and Usage Information that we collect consists of:

- Information About your Device: information about the devices and software you use to
 access our Website. This primarily includes the internet browser or mobile device on which
 you use your IP address or device ID (or other persistent identifiers that uniquely identify
 your computer or mobile device on the Internet), and other similar technical information.
- Usage Information: information about your interactions with the Website. This includes analytics such as device type, access dates and times, and hardware and software information. We use this information to administer and improve the Website, analyze trends, track visitors' use of the Website, and gather broad demographic information for aggregate use.
- Location Data: we may collect your location data through your IP address or if your mobile device permits such collection.

While we may temporarily collect this information while you are using our Website to facilitate usage, we do not log or retain it or associate it with other information we collect about you.

4. How We Use Your Information.

We may access your personal information for the following purposes:

- To improve, enhance and/or modify our services
- To provide information regarding features on our Website or changes to our policies
- To personalize content and experiences on our Website
- To engage in marketing our Website and services

In our capacity as a property manager or entity manager, we or our agents may access your personal information for the Properties only to deliver the required management services for such Properties and for other purposes solely as the property owner may authorize, unless prohibited under applicable law including:

- To process rental applications, customer reservations and participation in activities and events, and provide the customer with products and services
- To analyze, optimize, and improve the online experience, products, services and facilities
- To communicate with tenants, applicants, occupants, residents, boaters or customers regarding a reservation, rental unit, rental application or residential application, account, transaction, and information requests relating to a Property
- To post online or in other promotional materials the names, photos, videos, and other digital media of our customers, applicants, boaters, occupants, residents, tenants, and guests taken while at the Properties
- To administer and fulfill contests, sweepstakes or other promotions

- According to choices and controls that may be selected: To send users emails, offers, and promotions for our products and services
- To personalize content and experiences on our website

5. Disclosing Your Information

We may disclose your personal information as follows:

Service Providers

We may disclose your personal information with our service providers to provide services on our behalf, including but not limited to handling customer support inquiries, processing transactions, database management and digital marketing. Those companies will be permitted to obtain only the personal information they need to perform the service requested. We may also disclose your information to our third-party payment processors. In these instances, we only collect the billing address, first and last name and the last four digits of your payment card. In other instances, we may collect full payment card information, including all digits on the payment card. Please refer to the relevant third-party payments processors' policies to see how they handle your personal information.

Business Transfers

If we are involved in a merger, acquisition, sale, or financing of all or a portion of our assets, your personal information may be transferred as part of that transaction, but we will notify you (for example, via email and/or a prominent notice on our Website) of any change in control or use of your information or if either become subject to a different privacy policy. We will also notify you of choices you may have regarding the information.

Business Affiliates

We may share your personal information with our business affiliates as necessary or appropriate to enhance your experience and provide you with tailored services or to manage our relationship with you.

Complying with Legal Obligations and Security

We reserve the right to use or disclose information, including personal information, if required by law or if we reasonably believe that use or disclosure is necessary to protect our rights and/or to comply with a judicial proceeding, court order, subpoena, or legal process. In certain situations, we may be required to disclose your personal information in response to lawful requests by the government or public authorities, including to meet or assist national security or law enforcement requirements.

We also may disclose your information in the process of detecting and investigating fraud, security incidents and potentially illegal or prohibited activities, or to protect the safety or security of the Website and/or services or to prevent spam, abuse, or other malicious activity of actors with respect

to the Website and/or services, to protect our rights or property and/or the rights or property of those who use the Website and and/or services.

We will not discriminate against you in a manner prohibited by applicable state laws because you exercise your privacy rights. We welcome you to exercise any privacy rights, applicable to you. We provide users certain controls and choices regarding our collection, use, and sharing of information as set forth in our <u>Cookie Policy</u>.

2. Do Not Track
